THE MANOR OF THE DUNGEON, the mansion of which, situated just without the city walls, at a small distance westward from the lesser hill of the Dungeon, in the parish of St. Mary Bredin, has been pulled down for some years, and only part of the out-offices are remaining, with part of the garden walls.

This manor, now known by the name of Deanjohn farm, was formerly the property of an antient family called Chiche, one of whom, Ernaldus de Chich, was a person of principal note in the reigns of Henry II. Richard I. and king John, and the aldermanries of Burgate and Northgate, in this city, being then held as an estate in fee, did then belong to him and his heirs, and had continued for some time in his family. Thomas Chiche, who was one of the bailiffs of Canterbury in 1259, and again in 1271, was a principal benefactor to the above church of St. Mary Bredin. (fn. 1) John Chich was likewise one of the bailiffs of it in the 23^d and 26th years of king Edward III.
